STUDENTS' UNION ELECTIONS 2017 REGULATIONS

Students' Union Constitution Schedule I, Section G: Publicity in connection with Elections and By-Elections

1. Sponsorship or endorsement by a commercial entity is not permitted in any form. Sponsorship or endorsement includes, but is not limited to:
 - Branding, names or logos appearing on promotional material or t-shirts.
 - Gifts, vouchers or passes for commercial entities.
2. A candidate shall not distribute, nor cause to have distributed, any promotional material until 6:00pm on the Sunday before the election. Lecture Addresses are also prohibited until that time.
3. Each candidate, or their nominee, must attend a daily meeting with the Elections Committee during election week.
4. Any candidate who does not comply with the provisions of this Section of the Constitution shall be deemed ineligible for election to any post on the Executive Committee of the Union for that set of elections.
5. The Elections Committee will interpret the Election Regulations as they see fit and the decision of the Elections Committee is final.

Bunreacht Comhaltas na Mac Léinn, Sceideal I, Cuid G: Fógraíocht i dtaca le Toghcháin agus Fothoghcháin

1. Ní cheadófar urraíocht ná tacú ag aonán tráchtála in aon fhoirm. Folóidh urraíocht nó tacú na nithe seo a leanas, ach ní bheidh siad teoranta dóibh:
 - Brandáil, ainmneacha nó lógónna a thaispeántar ar ábhair bholscaireachta nó ar t-léinte.

3. Ní mór do gach iarrthóir, nó duine atá ainmnithe aige nó aici, freastal ar chruinniú laethúil leis an gCoiste Toghcháin i rith sheachtain na dtoghchán.
4. Aon iarrthóir nach gcomhlíonfaidh forálacha sa chuid seo den Bhunreacht, measfar nach mbeidh sé nó sí incháilithe chun a t(h)ofa chun aon phoist ar Choiste Feidhmiúcháin an Chomhaltais sna toghcháin sin.
5. Déanfaidh an Coiste Toghcháin na Rialacháin Toghcháin a léirmhíniú de réir mar a mheasfaidh sé is iomchuí agus beidh an focal deiridh ag an gCoiste Toghcháin.
